RoHS – Declaration of Conformity

We hereby confirm the conformity of our products according to the RoHS Directive 2011/65/EU or 2015/863/EU of the European Parliament and of the Council on the restriction of the use of hazardous substances in electrical and electronic components and equipment and compliance with the maximum allowable concentration in homogeneous materials in weight percent <0. 01% of cadmium, <0.1% of lead, mercury, hexavalent chromium (Cr6+), polybrominated biphenyls (PBB), polybrominated diphenyl ethers (PBDE), diphthalate (DEHP), butylbenzyl phthalate (BBP), dibutyl phthalate (DBP), diisobutyl phthalate (DIBP) according to Annex II of the Directive.

REACH – Declaration of Conformity

We are a so-called „Downstream User“ in the sense of the REACH regulation, as we neither manufacture nor import chemicals.

Therefore, we are neither subject to registration obligations according to REACH nor to the obligation to prepare safety data sheets.

Furthermore, to our knowledge, based on information from our suppliers, our products do not currently contain any substances above 0.1% by mass that are included in the so-called „candidate list“ pursuant to Article 59 (1,10) of Regulation (EC) No. 1907/2006 („REACH“).

In order to secure the supply chain and in the interest of highest product safety, we demand and pursue the implementation of REACH also on the side of our suppliers.

In doing so, we adhere to the obligation of the „ECHA Guidance for Downstream Users“.
